ORDER WITHIN VARIOUS COMMUNITIES IN MONMOUTHSHIRE**

NOTICE IS HEREBY GIVEN that Monmouthshire County Council of County Hall, The Rhadyr, Usk, NP15 1GA ("the Council") has made a Road Traffic Regulation Order as follows:

EFFECT OF THE ORDER:

- To extend the 20mph Speed Limit on the A4077, Gilwern (11th September 2024).
- To extend the 20mph Speed Limit on the B4598, Llancayo (11th September 2024).
- To extend the 20mph and 30mph Speed Limits on the B4293 and C57-4 (Itton Common Road), Itton Common (11th September 2024).
- To introduce a 20mph and 30mph Speed Limit on C26-2 (Pit-Wern-Yr-Heolydd Road) and C26-7 (Huntsman Lane), The Pitt, Llanarth (11th September 2024).
- To extend the 20mph and 30mph Speed Limits on the B4347, Grosmont (11th September 2024).
- To introduce a 40mph Speed Limit on the B4235, Llangwm (11th September 2024).
- To extend the 20mph and 40mph Speed Limits on the R71, Llansoy (11th September 2024).
- To extend the 30mph Speed Limits on B4293 and R83 (Devauden Road), Devauden (11th September 2024).
- To introduce a 20mph Speed limit on C23-2, Maypole and St Maughns (11th September 2024).
- To introduce a 40mph Speed Limit on the A466, St Arvans to Tintern (7th October 2024).
- To introduce a 30mph Speed Limit on the A466, Buckholt (11th September 2024).
- To introduce a 30mph Speed Limit on the B4245, Magor (11th September 2024).

The orders detailed above are scheduled to come into effect in a staggered manner on the dates specified in brackets.

If any person wishes to question the validity of the Order or any of its provisions on the ground that it or they are not within the powers conferred by the Act, or that any requirement of the Act or of any instrument made under the Act has not been complied with, that person may, within six weeks from **13th August 2024** (being the date the order was made) apply for that purpose to the High Court.
