Monmouthshire County Council (the 'Council') in exercise of their powers under the Road Traffic Regulation Act 1984 (the '1984 Act') and the Traffic Management Act 2004 (the '2004' Act) and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order:

1 CITATION AND COMMENCEMENT

The provisions of this Order shall come into operation on a rolling basis. The dates can be found against each provision in the table at 2(a) of this order marked 'Comes Into Force' (CIF). The order may be cited as Monmouthshire County Council Traffic Regulation, Speed Limits and Parking Regulations Consolidation Order 2019 (Amendment Order No.16) 2025.
